- 4. Editable form of application (4 pages) to be printed on vendor's letter head is made available under editable form.
- 5. All forms & formats for EOI should be properly filled.
- Attach all the relevant documents supporting the financial soundness and technical competency of the vendor duly signed & stamped as per the requirement mentioned in the vendor registration form.
